Parking permits for Stockholm

Local government permits

Parking permits for local government.

This permit may be issued to people or companies engaged in local on-call services who need to visit the parking facility regularly, mainly during inconvenient hours. The permit entitles the holder to park for free but, to the extent possible, within the restrictions of the parking regulations in force. Parking on grassed areas, in front of barriers or in any way that is not permitted.

On-call permit

Parking permit for companies with an on-call contract.

This permit may be issued to people or companies engaged in local on-call services who need to visit the parking facility regularly, mainly during inconvenient hours. The permit entitles the holder to park for free but, to the extent possible, within the restrictions of the parking regulations in force. Parking on grassed areas, in front of barriers or in any way that is not permitted.

Contractor's permit

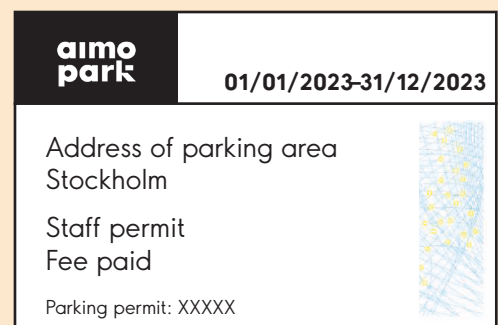
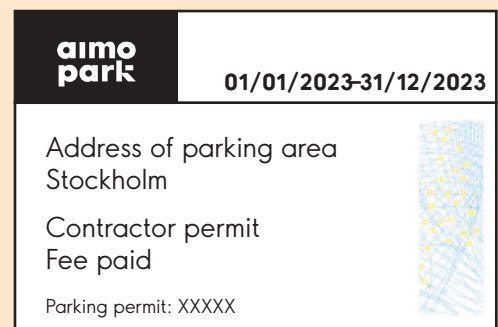
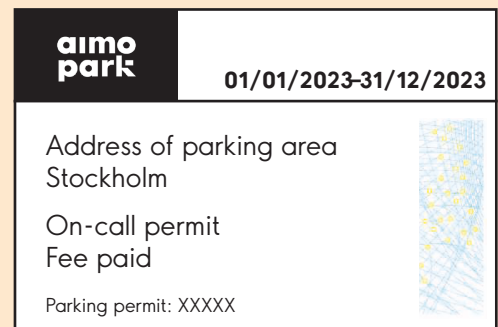
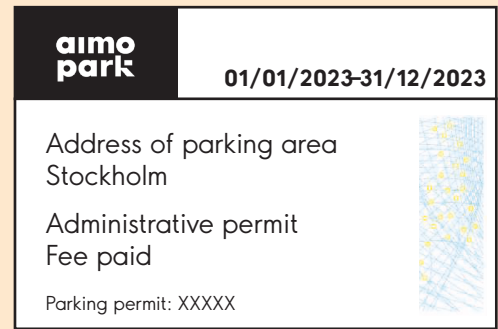
Parking permits for external contractors.

This permit may be issued to external persons or companies who perform contract work for the property owner and need to visit the parking facility regularly. This permit entitles the holder to park for free but, to the extent possible, within the restrictions of the parking regulations in force. Parking on grassed areas, in front of barriers or in any way that is not permitted.

Staff permit

Parking permit for staff.

This permit is issued to allow employees to park their car close to their workplace. The permit indicates that the employee is entitled to a parking bay on the site, and it may (if desired) entitle them to lower parking fees. The holder must comply with all parking regulations in force.

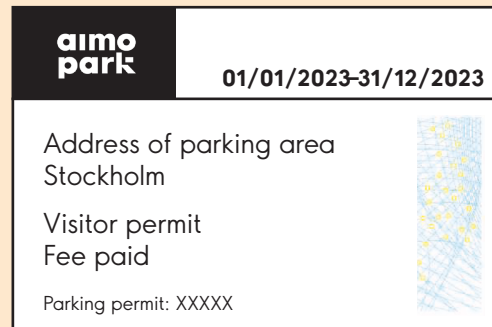


Parking permits for Stockholm

Visitor permit

Parking permit for visitors.

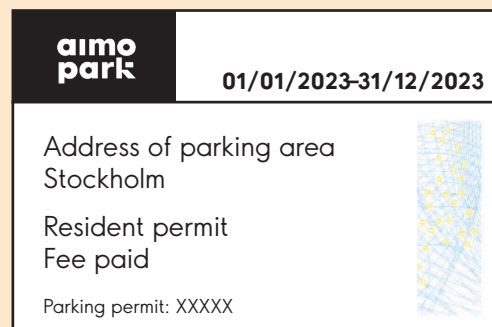
This permit is issued to visitors who need the ability to park, for example, at a work place or in residential parking, for a limited time. The holder must comply with all parking regulations in force.



Resident permit

Parking permit for residents.

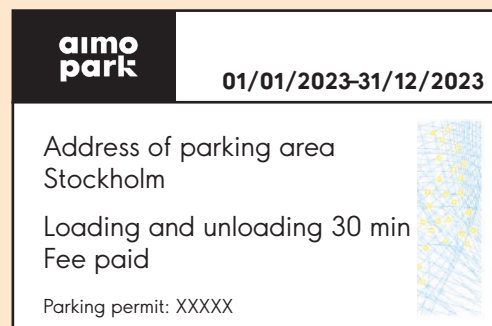
This permit may be issued by housing associations or housing companies, for example, that want to allow residents to park next to their homes. The permit shows that the resident is entitled to a parking bay on the site, and it may (if desired) entitle them to lower parking fees. The holder must comply with all parking regulations in force.



Loading and unloading

Parking permit for loading and unloading

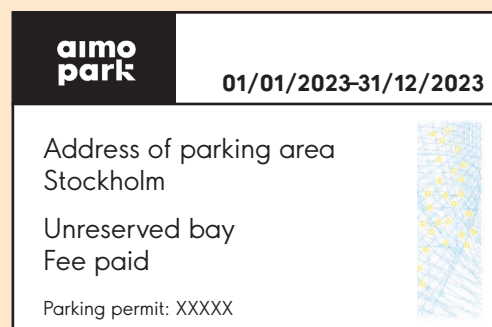
This permit may be issued to individuals or companies who, for special reasons, need to park in zones where parking is actually prohibited. The permit entitles the holder to park for 15, 30, 45 or 60 minutes. You decide the time period for yourself.



Unreserved bay

Parking permit for unreserved bay.


This permit entitles the holder to park - subject to availability - on the days and times the permit is valid. The holder may park for free for the agreed amount of time and does not have to pay any fee at the pay station. Parking regulations in force must be observed. Parking is not permitted in the reserved/rented bay.



Reserved bay

Parking permit for reserved/rented bay.

This permit entitles the holder to park - in a specific parking bay - on the days and times the permit is valid. The holder may park for free for the agreed amount of time and does not have to pay any fee at the pay station.

Temporary parking permit

Temporary parking permit.

This permit entitles the holder to use a specific parking facility for a limited period of time. You choose the area, the type of land and how long (maximum 28 days) the permit is valid. Temporary parking permits are recommended, for example, for construction work or moving house.
